
1. The DSSSB vide its vacancy notice/Advertisement No. 03/23 dated 10/11/2023 with closing date 20/12/2023 had advertised **Total - 13 [UR-08, OBC-03, SC-01 & EWS-01]** for the post of Assistant Section Officer under Post Code-101/23 in SCERT.
2. The Tier-I CBT for recruitment in respect of this post was conducted on 14.08.2025, 18.08.2025 to 22.08.2025 & 27.08.2025.
3. The Normalized marks obtained by 17014 candidates who appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dsssonline.nic.in.
4. Based on the performance in CBT Tier-I(MCQ) for 200 marks, the candidates who have secured equal or more marks in their respective category as per the details given below in the table have been provisionally shortlisted for Tier-II subject to correctness of the information furnished by the candidates in their online application forms

5. As per the Examination Scheme, Tier-I examination is only qualifying in nature and used for category wise shortlisting of candidates only. Further selection will be made on the basis of cumulative merit/marks obtained in Tier-II examination.
6. Only those candidates have been considered in OBC Category who has declared that they are OBC (Delhi) in their online application form.
7. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II does not entitle them any right over the post.
8. The above shortlisted candidates for Tier-II for the post code mentioned above will be subject to outcome of pending court cases, if any.
9. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any,

detected at any later stage.
